

Privacy Policy

We at Pennsylvania Coalition for Innovation and Competition respect your concerns about privacy and value the relationship we have with you. This Privacy Statement describes the types of information we collect on innovatepa.org, how we may use that information and with whom we may share it. Information We Collect and How We Use It

Information We Collect On You

The Pennsylvania Coalition for Innovation and Competition allows you to sign up to receive future communications and resources about legislative and regulatory issues in Pennsylvania. If you email us through the [Contact Us](#) link on this site, we ask you for information such as your name and email address in case your question or comment requires a response. Unfortunately, we may not be able to respond to all messages, but we value your input.

Other Information We Collect

We also collect certain aggregate and non-personal information when you visit this website. Aggregate and non-personal information does not relate to a single, identifiable visitor. It tells us things such as how many users visited our site and the pages accessed. By collecting this information, we learn how to best tailor this website to our visitors. We collect this information through “cookie” technology as explained below.

Cookies

Like many websites, we use “cookies” on this website. Cookies are bits of text that are placed on your computer’s hard drive when you visit certain websites.

Cookies allow us to “customize” your user experience.

The “help” portion of the toolbar on most browsers will tell you how to stop accepting new cookies, how to be notified when you receive a new cookie, and how to disable existing cookies. Remember though, without cookies, you may not be able to take full advantage of all our website features.

Information We Share

We do not sell or otherwise disclose information about you, except as described here. We may share the information you provide with members of the Pennsylvania Coalition for Innovation and Competition. We also may share information provided by our website visitors with service providers we have retained to perform services on our behalf. These service providers are required to use or disclose the information only as necessary to perform services on our behalf or to comply with legal requirements.
